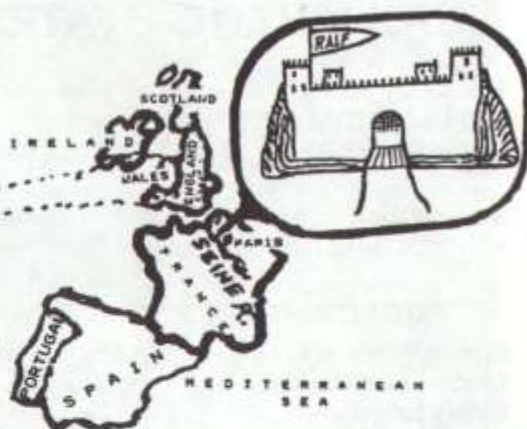

We promised you a ballot with this issue. The following issues are available for your approval or rejection.

Your approval of the MEMBERSHIP BILLING CHANGE on the enclosed ballot will end our practice of mailing TRAILS for a year in the hopes that the member will renew and we will avoid the expense of having to pay first class postage to mail back issues. It will end the year long grace period that we have been extending to members. Although we have not publicly announced this liberal grace period, three or four seem to have caught on and conveniently "forget" to renew about every other year.

This practice has not been fair to the members who renewed on time. We feel it should be discontinued. We do not feel that it is fair for those who renew on time to have to shoulder the additional expense created by a few who do not.

This will bring our renewal system in line with our current policy of charging new members \$17.00 if they want to be billed for membership instead of enclosing \$15.00 with their Application for Membership.

Some of our officers feel that our practice of publishing the phrase "your silence will be considered approval" in connection with elections in an effort to save postage may not be adequate in the event that someone challenged an office or action.

She shared the following pleasant memory:
 Before going to England & Scotland in May of 1988, I did a bit of research at the library getting info on the TERRELLS in England (my mom's family) and also finding a map of Essex County. It paid off.

We left London for Brentwood, Essex County. I went into the post office to inquire about East Thorndon and/or Herndon. **Nancy SAVILL** was waiting in the stamp line behind me. She asked if she could help me. (Brentwood is a small town where strangers are easily identified.) I asked if she could help me locate the above area. "Oh, Happy Day!" She lived near there. When I mentioned the TERRELLS, she told me that everyone in town knew about **Sir Walter TYRRELL** and how he killed **King Rufus**.

She directed us to the old Parish Church where TYRRELL records are kept. It is atop along hill, in an old brick building. Services are no longer held, except for special occasions & concerts. It is supported by the Church of England and private gifts. It is called All Saints Church and has an old (as in ancient) graveyard to one side.

NOTE: Collier's Encyclopedia (1957 ed) listed under William II, p 488 "William was accidentally killed, perhaps by Walter Tirl, while hunting in the New Forest on August 2, 1110.

The **TERRILL HOME FOR FUNERALS** is (or was) located in Irvington, Essex Co. NJ. Booklet 1A covers 07/13/1916--05/19/1922. Booklet 2 covers 10/01/1928--10/29/1936. Booklet 3

covers 11/01/1936--09/09/1946. Each booklet contains about 100 three hole punched pages and is \$12.00 each. The same information is available on 3 floppy disks @ \$6.50 each. Each booklet contains an alphabetical listing of all names and a date followed by numbered pages containing the following information on each individual: surname; given names; exact age; date of death; interment date; occupation; father's name; reference; spouse's name; place of birth & date of death; cemetery; funeral ordered by; mother's name; book and page of original record. We do not know how many (if any) **TERRILL/TERRELLS** were handled by this funeral home.

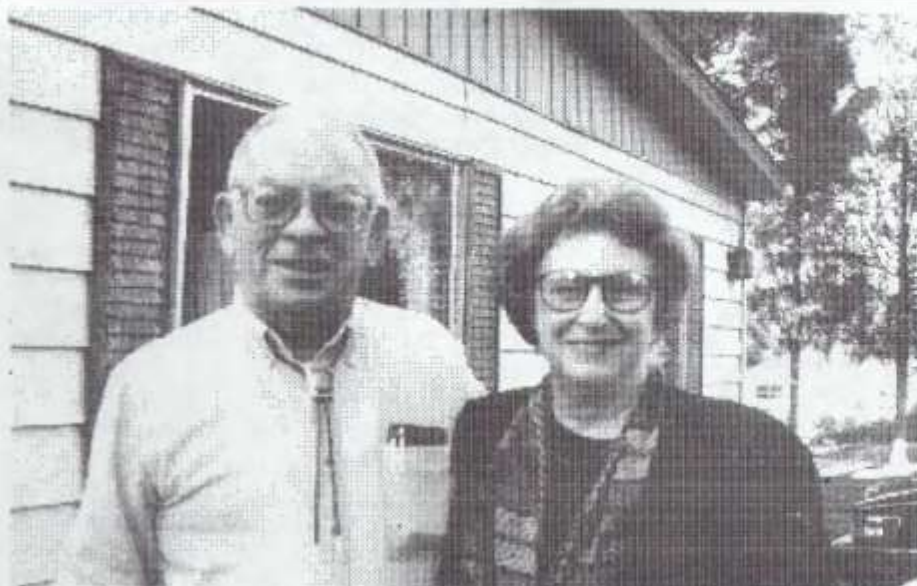

QUESTIONS & CONFLICTS

A paper written by Virginia Greene DePriest (DePriest statements in quotes) listed the following conclusions:

1. That George HAMBRICK, (from Germany 1731), married a Nancy COOK. "This statement is very much in doubt."
2. Children of George HAMBRICK and wife Nancy COOK: George HAMBRICK md. Susanna BLANTON. Benjamin HAMBRICK md. Fannie BURCHETT. Moses Richard HAMBRICK md. Mary BRIDGES. "This generation is also in doubt."

Will Book A1 1823-29, Pike Co. GA, page 127, Court of Ordinary, March Term 1829 appoints Clary HAMBRICK administrator of the estate of James HAMBRICK late of Jasper County deceased when she gave Ignatius TERRELL for surety in a bond of one thousand dollars and was qualified in terms of law... Although this does not disclose the contents of the will, it clearly establishes a relationship between James HAMBRICK, Clary HAMBRICK, and Ignatius TERRELL.

Wilkes Co. GA Deed Bk CCC page 211, 01/11/1817 deed, James HAMBRICK and Clara, his wife, of Lincoln Co. GA to Moses & Aron HAMBRICK of Wilkes Co. GA for \$500.00, 94 acres adjoining Thomas MONCRIEF, William MONCRIEF, & Daniel BESS. Dower endorsement for Clara. Deed signed James X HAMBRICK, Clara X HAMBRICK. This places James & Clara in Lincoln Co. GA at that time and indicates a probable relationship with Moses & Aaron, but does not help resolve the issue of ancestry.

1830 Census, Pike Co. GA, page 133: Clarissa HAMBREC 00201-0201001 (b. 1780-90)

1840 Census, Pike Co. GA, page 119: Clarissa HAMBRICK 00001-00021001 (b. 1780-90)

Pike Co. GA, Will Bk. C, page 118 lists the will of Clarisy HAMBRICK signed 04/09/1830. The photocopy of the microfilmed page showing a copy of Aaron's affidavit that this is his mother's will appears to be dated 1834. The copy contains a penciled in date of 10/02/1854 that apparently was on the film. The next document on the page seems to be dated 1834, making the earlier date appear more likely to be correct.

If the 1834 date is correct, who is the Clarissa in the above census?

[*Editor's Note:* A trip to Pike Co. GA to view the original documents will probably be required. A copy of the record cited was not included, so I can only speculate. Was the will being proven in 1834, or was it simply recorded for security? There have been a few instances where a will was recorded before the death. If she did not die until 1854, there should be another record somewhere administering the estate. A woman born in 1780 would be only 74 in 1854, and it is possible that the above Clarissa was the widow of James. Clarissa was a fairly common girl's name. Alternatively, she could have been the widow of one of the other HAMBRICK men of James' generation. The conflicting records on James list his birth as ca1762 & ca1777 respectively. Clary would probably have been younger, and may have been much younger than James.]

These items seem to establish that James HAMBRICK's wife was Clara, and identifies 5 children, Aaron HAMBRICK, Nancy A. HAMBRICK, Martha HAMBRICK, Elizabeth HAMBRICK Bethune, & Mary HAMBRICK TERRELL. However, the question remains, who were the parents of James HAMBRICK/HAMBRICK who md. Clary and died before 1830 in Pike Co. GA? DFB

Frederick Reynolds TERRELL; helped lead Patton's air support

Retired Air Force Maj. Gen. Frederick Reynolds TERRELL, who was second in command of air support for Gen. **George PATTON's** Tunisia, Sicily, & Italy campaigns during WWII died Monday at Tri-City Hospital in Vista following a stroke. He was 82.

"The longtime Lake San Marcos resident will be remembered as a top notch officer who earned the respect of a wide circle of friends" said **Dwight O. MONTIETH**, a retired Air Force General and West Point classmate.

Gen. TERRELL, a 10th generation American, was born at Booneville MO. He grew up at various places throughout the Southwest following his father, an Army officer. He graduated from Los Angeles High School. He was appointed to the U S Military Academy at West Point by then- President **Herbert HOOVER** after placing third in a national exam and graduated in 1936. He earned his pilot's wings the next year at Kelly Field TX.

He married the former **Annie Lee LANCASTER** of Corpus Christi TX in 1938 during a tour of duty in Hawaii. Mrs. TERRELL died in 1987.

Gen. TERRELL was in California at the outbreak of WWII, commanding the 97th Reconnaissance Task Force. He was assigned to North Africa in 1943 as deputy commander of the Mediterranean Allied Bomber Task Force in support of American troops fighting their way to the Italian peninsula.

Gen. TERRELL finished the war at the Pentagon as assistant deputy chief of staff of the Army Air Force, and joined the new Air Force when it was separated from the Army in 1947.

He was awarded the Silver Star and the Bronze Star with clusters for his service during WWII, and was deputy commander of the 20th Air Force during the Korean War.

Gen. TERRELL also was an instructor at the National War College at Maxwell Air Force Base AL; commander of a Nike-Zeus anti-ballistic missile task force, and commander of the 30th Air Div., with responsibility for firing ICBMs in the mid-western states.

Gen. TERRELL retired after 30 years of service in 1966 and moved to Lake San Marcos the following year.

He was an active member of Kiwanis and supported a number of charities including the Disabled Veterans of America. He

was an avid golfer, fisherman, and pursued an interest in the history of California.

Gen. TERRELL is survived by a daughter, **Priscilla Ann TERRELL Brody** and a son **Frederick Kenyon TERRELL**, both of San Diego, and two grandchildren.

He will be cremated and buried at the family plot in Altadena. There will be a memorial service at 11 am Dec 24 at the United Church of Lake San Marcos.

The doctor spent his boyhood years in Trumbull county, OH where the Tyrrells settled in 1806; there received a good common school education and in later years was a student in the academy at Warren, OH. Subsequently, he engaged in teaching school, and thus secured means to "push through" a course of medical studies. Again we find him a student at Meadville academy, PA, and next completing an eight months' course at Allegheny college there. Meantime, he studied under Dr. JOHNSON of Vienna, OH, and later engaged in practice with his old preceptor.

Returning to the farm, he found himself still practicing medicine, being so often called upon. After three years, he purchased a farm continued in agriculture, school teaching, and medicine for many years.

In 1853, he went to Hancock county, IL and was engaged in practice with his brother for six months until he was sent for to attend on his wife. He returned to Ohio. She, Minerva ALDERMAN Tyrrell, died of consumption (Tuberculosis) which she had twice been relieved years before. He moved to IL in 1855 and engaged in practice with his brother, Abijah TYRRELL, then at St. Mary's.

His four sons by this marriage are: Edwin H. TYRRELL of Toulon; Sylvanus M. TYRRELL of Chicago, a machinist and natural mechanic; Gilbert R. TYRRELL of La Porte, IN, first president of the N.W.Indiana Bee-keepers' Assn., master mechanic; and Calvin C. TYRRELL a carpenter, painter, and farmer of Hancock county IL.

In December 1857, the doctor moved to Claremont, NH where he md. Miss Frances Augusta HUNT, a graduate of a medical college and a lady of extraordinary good literary and social attainments who had a large practice among women and

children. They practiced medicine there until 1861 when they moved to La Porte IN, where in the fall she had ovarian tumor weighing over thirty pounds taken out by Prof. A. CURTIS, MD of Cincinnati Ohio assisted by her husband, Dr. TYRRELL. The eighteenth day after the operation, she rode out and visited patients. Their only daughter, weighing only three pounds, was born the next May 8, 1862, later Mrs. Hattie H. BERGER of Salinas CA.

The doctor's son, Sylvanus TYRRELL, enlisted in the 5th NH regiment in the summer of 1861 after writing in New Hampshire to La Porte IN for his father's consent which was freely given after telling his son of the hardships, exposures, and privations of a soldier, and that he thought there would be more danger in the hospitals than of Rebel bullets. Sylvanus was in every battle and skirmish that his regiment was in for three years and was hit but twice by Rebel bullets. He was Orderly Sergeant.

Gilbert TYRRELL enlisted in La Porte IN in the 35th Indiana Regiment and was wounded in battle near Kennesaw Mountain, July 20, 1864 and sent back to Nashville TN. He got a small pension and lived in a nice large residence of his own construction on Indiana Avenue in La Porte IN.

The doctor himself served as surgeon in the army in 1864-5. In the hospitals of Rome, GA, he was frequently called to visit other surgeons' patients after it was known that such cases as were dying day and night under "old school" treatment were getting well under his Botanic treatment. He was in the Fifth-third Illinois Regiment on march through GA and was surgeon-in-charge of the officers' hospital and a Rebel hospital in Savannah GA in the winter.

In March 1865, he was surgeon-in-charge at the small pox hospital at Blair's Landing, SC; and at other times and places was in other hospitals, fields, and convalescent camps, and was called "the Soldiers' Friend." He was an officer on the medical staff at Gen. SHERMAN's grand review in Washington DC and surgeon of the Thirty-second OH regiment on Georgetown Heights DC, and of a hospital on Washington Heights. Being in Washington frequently, he visited all of the government buildings, inside and out, from the White House and Capitol to the magnificent hospitals. The tents whitened the country as far as he could see from the dome of the Capitol. In July, 1865, he was surgeon of the Pioneer Corps, near Louisville, KY.

While the doctor was in the Army, Mrs. TYRRELL went to Emporia KS to visit her mother and sister and was soon engaged in a good practice. They persuaded him to move to Emporia. On the way there, he came to Toulon, on account of the "land sharks" taking possession of 160 acres of land near Toulon after the doctor had a warranty deed and had paid the taxes eleven years. He has an 80 acre farm of it yet. On arriving at Ft. Leavenworth KS he heard of his wife's death which took place at her mother's October 12, 1865.

The next fall, he came to Toulon just within the old settlers period of this county. On November 27, 1867 he married Louisa STODDARD Goodheart, formerly of NY state, then the mother

of five children. They are: Calvin C. GOODHEART of Wymore NE; Mrs. Alice GOODHEART Rice of Colville, Washington Territory; Samuel H. GOODHEART of Toulon township; Mrs. Mary GOODHEART Addis of West Jersey township, and Joseph O. GOODHEART of Albion, Harper County KS.

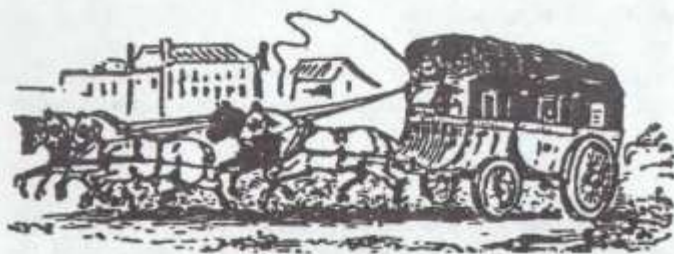
Mrs. Tyrrell and her family are members of the Christian church. She and the doctor own a beautiful home at Toulon, a rich farm of 160 acres with large residence in Hancock county IL, 160 acres two miles east of Nelson NE, and two lots in Hasting NE, besides the eighty acre farm and a few lots and extra houses at Toulon for rent.

The doctor has received three medical diplomas. After receiving the second, he attended lectures in five other medical colleges, and clinical lectures in the hospital, and engaged in practice with Prof. A. CURTIS in the Infirmary and city of Cincinnati OH and Covington and Newport KY. He has frequent calls yet from different states: NH; PA; OH; IN to CA; OR & WY territories, for prescriptions and advice.

He advocates temperance in all things and is opposed to all strong drinks and tobacco. Having studied all systems of medicine, he holds fast to the botanic and hygienic (physio-medical), using nature's remedies.

He had four sisters and three brothers. The first four were born in Fairfield CT, the others were born at Tyrrell's corners, Trumbull OH. His father and brothers appeared to be natural mechanics. The oldest brother, when a small boy in his father's blacksmith shop, made Jews harps, pocket knives, etc., then different kinds of bits, augurs, and all kinds of joiner and carpenter tools; then built barns, houses, sawmills, and later, steam engines for mills and factories.

His brother, Dr. Abijah TYRRELL, MD was called out with his company by the governor at the time of the Mormon war at Nauvoo, IL. (Source: *BIOGRAPHY AND REMINISCENCES OF TOULON TOWNSHIP*, pages 407-410, publisher and publication date not submitted, but from references to Washington, Oregon, and Wyoming territories, probably was published before 1900. Dr. & Mrs. TYRRELL were still living at publication, or at least during research for the book.)



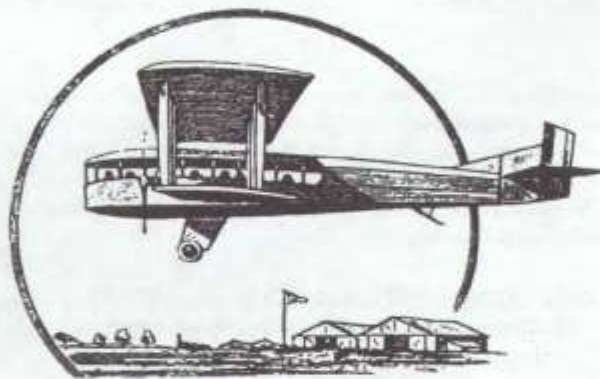

Enlisted as Pvt. in Capt. HARPER's Light Inf. Co. of Virginia Volunteers in November 1846; transferred to Mexico during the Mexican War and died there of disease. A pension of \$3.50 per month was granted to widow in September 1860; application # 13975; certificate # 507; as of 1857, she lived in Albemarle Co. VA. His parents were Henry Chiles TERRELL (09/14/1766--?) and Philadelphia SMITH (of Greene Co. VA). Twenty-seventh Governor of Arkansas
 Thomas Jefferson TERRAL
 (21 Dec 1882—9 March 1946)

Thomas Jefferson TERRAL was born in Union Parish, Louisiana, the son of George W. and Cecelia CALK TERRAL. His father was a moderately successful merchant and planter. He instilled in his son traditional Southern values that included hard work and the Baptist church, the Democratic party, economic conservation and education.

Thomas attended public schools in Louisiana and Mississippi and took college level work at the University of Kentucky and the University of Arkansas. Determined to make Arkansas his

adopted state, he petitioned for and gained admittance to the state bar the year of his graduation from law school.

Thomas began his political career in 1911. In that year he was appointed assistant secretary of the Arkansas State senate. when the general assembly adjourned he was able to secure a position as assistant to the deputy state superintendent of public instruction. He filled that post through 1916 except periods when the general assembly was in session in 1913 and 1915.

Thomas married early in his career to Eula TERRAL, daughter of Nathaniel TERRAL. They had no children.

In 1916 Thomas made his first statewide political campaign. Eschewing all local races, he entered the Democratic primary as a candidate for the party's nomination as secretary of state. He proved to be an excellent campaigner, and by building on the friendship he had made as secretary of the senate he was able to win the nomination easily. He was elected in the fall of 1916. Reelected in 1918. Thomas served as secretary of state for four years.

His record in office was auspicious enough that he offered himself as candidate for the Democratic nomination for governor in 1920. He ran third in a field of nine, a showing that suggested considerable support. During the next four years, while he practiced law, he maintained and even increased his political contacts across the state.

By 1924 as Governor Thomas Chipman McRAE's term of office was drawing to a close, Terral prepared to make another try for the Democratic gubernatorial nomination.

The 1924 primary race attracted six candidates, including Terral. He ran a vigorous campaign that included some two hundred speeches on a platform calling for reduced taxes, greater spending for education, better roads, more law enforcement, and respect for the constitution ultimately spelled success for Terral's gubernatorial ambition. On 12 August 1924 he polled 53,628 votes of the 196,893 cast. CAZORT, the runner up, received some 12,000 votes less. Terral's nomination was virtually guaranteed. In the general election on 7 October 1924 easily defeated Republican John W. GABRIL.

Terral was inaugurated as governor on 13 January 1925. His initial speech to the forty-fifth general assembly set the tone for his administration. He declared himself to be in strict favor of enforcement of state laws, especially relating to the prohibition of alcoholic beverages and the carrying of concealed weapons.

He recognized that the McRae administration had doubled the amount of state money expended per school child annually to \$5, but he believed that even more could be done. Accordingly, Terral recommended that the general assembly levy taxes on certain luxuries like chewing gum and cosmetics for the purpose of increasing the per capita allocation to \$10 per child. He also proposed that revolving loan funds be created at the University

of Arkansas in Fayetteville and at other state colleges that would provide sources of monies from which students could borrow to help finance their educations.

With reference to the public road system that had caused so much grief for his predecessor, the governor applauded the contributions of the McRae administration--especially the Harrellson Act and the four-cent per gallon gasoline tax--but he urged an additional one-cent-per gallon tax on gasoline and a greater percentage allocation of tax revenue to the counties. The latter would help relieve the indebtedness stemming from the old road-improvement districts.

Despite recommendations for increased taxes to benefit education and roads, Governor Terral was primarily interested in economy and efficiency in government. His inaugural address contained numerous recommendations about how this could be achieved. Foremost of these was his demand that honorary boards and commissions utilized in state government be either eliminated or consolidated.

The members of these groups served without pay, but their expenses incurred in attending meetings, which were reimbursed by the state, seemed unnecessarily large. Accordingly, he suggested that eleven of the board and commissions with a membership of sixty-two people be reorganized into a permanent three-member board of charities and committees. The members of the board would be paid, but their aggregate salaries would be less than the total annual expenses of those who currently served on the boards.

Terral also recommended that the duties of six different revenue collecting agencies be consolidated into one department of insurance and revenues. Moreover, he insisted that a department of conservation and inspection be created that would incorporate the inspection and chemical-analysis of three agencies. This plan, he said, would prevent duplication of efforts and would eliminate the jobs of ten state employees.

The governor also demanded that the legislature abolish the state game and fish commission, an agency that cost the taxpayers \$80,000 per year. This money should be transferred to the educational system and utilized to protect children instead of wildlife. Game and fish laws could be enforced by county sheriffs and deputies.

The governor made a host of recommendations designed to foster efficiency in government. Among these was a constitutional amendment increasing the number of Supreme court judges from five to seven.

In the main, the general assembly responded favorably to the governor's principal recommendations. It consolidated the revenue collecting activities of the state government into a new department of insurance and revenues, and it combined all inspection and chemical analysis functions into a department of conservation and inspection.

Despite the opposition of ex-governor McRae who termed the enabling legislation "the most dangerous piece of political work ever proposed in the history of Arkansas," the general assembly abolished eleven honorary commissions and created in their place a salaried three-member Board of charities and corrections. It also created the revolving loan fund for university and college students proposed by the governor, and even authorized building programs to be financed by the revenue bonds at university at Fayetteville and the colleges at Conway and Russellville.

The legislature also adopted a measure permitting construction of a state general hospital in Little Rock, an item of vital importance to the university's school of medicine. It did not approve additional excise tax to increase the public school fund.

At the same time, it did adopt and refer to the electorate a constitutional amendment increasing the number of Supreme court Judges. This amendment and one allowing initiative petitions and referendum ballots were later adopted by Arkansas. Not a part of the governor's program, but one that he came to support, a measure creating Arkansas's first state park at Petit Jean Mountain was also approved.

In some matters, Governor Terral got less cooperation from the general assembly than he desired. This lack of cooperation was especially true with reference to the road program.

Anxious to relieve the tax burden of those property owners who had borne the brunt of onerous highway construction costs, some legislators urged that the state sell several million dollars worth of new bonds; the revenue from these bonds would be used to reduce the indebtedness of those counties where the construction had occurred.

As such a plan would effectively transfer the debt from the local level where it had been incurred to the other level where it had not been, Terral adamantly opposed it. Only with the greatest effort, which included a statewide conference held to consider the question, was the governor able to defeat it.

The general assembly responded to Terral's opposition by agreeing to levy the additional one-cent-per gallon gasoline tax he had recommended, which resulted in no additional money for the state highway program.

The legislature also declined to abolish the game and fish commission as well as other state offices the governor considered unnecessary. In other matters its spirit of independence was no longer evident, over the governor's objections, it legalized Sunday baseball and licensed physicians who did not meet the requirements of medical examining boards.

Terral vetoed these measures after the general assembly adjourned.

In comparison to the legislative sessions during the administrations of Governors McRAE and BROUGH, the results of the session that convened in 1925 were hardly auspicious.

In part, this situation was due to the fact that Governor Terral had asked so little of the general assembly. Its record was uninspired, because Terral had failed to challenge it with something other than a program designed merely to mark time and save money.

Ironically, the governor considered the results more as signs of virtue than of failure. He was proud of his accomplishments and believed that he had kept faith with those Arkansas who had elected him to office. Indeed, he was certain that his record would guarantee him another two-year term as governor.

That Terral was not entirely wrong in his assessment of his administration became apparent during the Democratic primary campaign held in the summer of 1926. Only one candidate, John E. MARTINEAU of Little Rock, came forward to challenge him. And had the election been held earlier than it was, Terral undoubtedly would have won. But Martineau proved to be a formidable opponent, and toward the end of a bitter campaign he accused the Governor of malfeasance in office.

Two of his charges seemed to be most telling: the governor had shown favoritism to the American Book Company in selecting books for use in public schools, and he had accepted a partially paid-life insurance policy in return for channeling the state's fire-insurance business to a particular agent.

The governor largely ignored these accusations and tried to direct attention to the positive accomplishments of his administration. Specifically, he emphasized his support of prohibition and his opposition to a state bond issue to absorb the indebtedness of the independent road districts: he boasted that his administration was the first in twenty years not to raise taxes, that there had been no special sessions of the general assembly, that he had prevented Sunday baseball, that he reduced the cost of state government by \$35,000 per year, and that he had secured a student loan fund and launched a building-construction program at the colleges and university.

Unfortunately for the governor, this record was not as compelling to the electorate as Martineau's well-timed charges were. On August 10, 1926 Terral received some 101,000 votes, but his opponent tallied more than 117,000. The governor had run well, but not well enough.

During the remaining four months of his term, Terral conducted his administration no differently than he had during the previous twenty months. He kept the offices of state government open and insisted that employees work economically and efficiently, merely marking time until others with a different vision for Arkansas assumed the governorship.

For almost two decades thereafter Terral engaged in the private practice of law in Little Rock where he died on 9 March 1946 after a long illness. He was buried in Roselawn Memorial Park.

EULA TERRELL TERRAL

Descended from Sir **Walter TYRRELL** of England (1066 et seq) via the name established in this country by [sic] **William, James, & John TERRELL** who received grants from the King of England for 1500 acres in Virginia in 1687; born at Garnett, AR, dau. of **Nathaniel G. TERRELL & Isabelle Caroline JOHNSON**; siblings: **Edward Street TERRELL**; **Ellen TERRELL Gammil**; **Iola TERRELL Jones**; **Nettie TERRELL**; & **Troy TERRELL**.

Her mother, **Isabelle Caroline JOHNSON** was born in Winstboro, SC and moved to Arkansas as a young girl. Her mother, **Ellen Strother WOODWARD Johnson** was descended from **Thomas WOODWARD** who came from England in the company of **Lord BALTIMORE**. His son, **Thomas WOODWARD** was an extensive land owner in SC, a close friend of **George WASHINGTON**, and served as Regulator in the American Revolution.

Thomas JOHNSON, paternal ancestor of Mrs. **Nathaniel G. TERRELL** moved in 1817 from Worcester MA to SC and became a prosperous slave owner there. That branch of the family also served in the Revolution. Mrs. **TERRAL's** grandfather, **Thomas JOHNSON, Jr.** served in the Confederacy.

Being one of a large number of children probably helped to form her characteristically liberal viewpoints, personal and political. A spirit of tolerance, reason, suavity, intelligence she carried into high official realms doubtlessly had its roots in cooperative effort engendered and fostered in the group world of her childhood. She laid the foundation for her future of importance by following a wholesome physical and intellectual program.

She enjoyed tennis and horseback riding, but had no recreation for which she would abandon a book. She was well read at an early age.

She attended the public schools at Garnett, graduated from high school, had junior college preparation and attended the University of Chicago from which she graduated. She had a gifted singing voice and devoted 4 years to its development in Chicago.

She and **Thomas Jefferson TERRAL** (above) were married at Pine Bluff, AR on February 25, 1914 in a beautiful afternoon ceremony. The vest man was **George Washington HAYES**, State Magistrate of that era.

A small apartment in Little Rock became their first home and Mrs. **TERRAL** began a life connected with politics regardless of a reputed distaste she had for the profession per se. Relegating personal inclinations, ever before her from then on was the idea of her husband's ambitions and her boundless joy in furthering them.

When Mr. **TERRAL** became a candidate for Secretary of State, Mrs. **TERRAL** became the campaign manager. She provided space in their housekeeping rooms as political headquarters, ably directing with ease, courtesy, and driving force, the contest that brought success. She took her place in campaign headquarters again in 1920 when Mr. **TERRAL** waged his candidacy for the governorship.

Although that campaign was unsuccessful, four years later, she was again at the front of her husband's battle. At his inauguration as Governor of Arkansas on January 14, 1925, their home at 1118 Wolfe Street became the State's official domestic house.

Mr. **Dallas HERNDON**, historian, astute observer, and recorder of public affairs, said, "The story of her life could not be without saying that the State of Arkansas never had a more charming first lady than Mrs. **Tom J. TERRAL**, the wife of former Governor **TERRAL**. Besides the beauty of face and form, which she possessed, she had a very charming personality that completely won the hearts of all who had the good fortune to come in contact with her. She was, and is, a person without a semblance of ostentatious pretense, and her simple graciousness and modesty, which are of the heart, lent a tone of dignity to the position of the first lady which has never been surpassed."

Eula TERRAL wore a white satin formal gown beaded in seed pearls and rhinestones, with complementing American Beauty roses to the inaugural reception. A ball was given in their honor by the Arkansas National Guard. They attended as gubernatorial guests the opening of the Arlington Hotel in Hot Springs. Eula was always clothed in dress flawless in appropriateness. Among many noted houses guests during their tenure of the "Governor's Mansion" was **Mary LEWIS**, paying her first visit to Little Rock as a singer of national celebrity.

Travel before and after marriage carried her into much of America. One vacation while he was Governor was spent in Canada and the Eastern United States including a call on then President COOLIDGE. The TERRALS were recipients of a White House reception.

She was an expert card player in her favorite game of Bridge. She gave herself generously to civic calls, club work, the latter particularly where her sponsorship of music and art will give support. She was a member of many organizations and met her obligations to the letter. She was a Baptist.

Governor TERRAL paid her the ultimate compliment, "My success, whatever I have attained, was brought about by the hard work of my grand and faithful friend. Without her charming personality, keen mind, and sparkling mannerisms, I would have failed in my political career. To know her is to love her, and I dedicate to her all the glory I may have attained in my political life, no truer friend ever graced the home of any man than my friend--my wife."

Carr MOORE was born in Fordyce AR on Dec 18, 1885; daughter of Dr. Miles Smith MOORE and Pathenia Elizabeth FAUCETT. On July 19, 1904 at Red Fork AR, she became the wife of Edward Street TERRAL [brother of Eula TERRAL above] who d. 1945.

Mr. & Mrs. TERRAL resided for many years in Tillar where Mr. TERRAL was a member of the firm Tillar Mercantile Company serving in the capacity of manager and buyer for the store.

He was an enthusiastic supporter of Ouachita Baptist College and a member of its board of Trustees; served as president of the Citizens Bank of Tillar; President of the Tillar School Board; and President of McGehee Bank.

They were the parents of two children: Stacy Moore TERRAL & Oneita Elizabeth TERRAL; both of whom died in infancy.

Following the death of Mr. TERRAL, she moved to Dumas where she has since made her home. She has held various offices in the Parent Teachers Association; the Tillar Cemetery Association; American Legion Auxiliary; Highway Garden Club; Order of the Eastern Star; and is a member of Amaranth Court No. 1.

She holds a life membership in the Hospital Auxiliary; and has been responsible for the redecoration of three rooms at Dumas Hospital as memorials to Edward Street TERRAL, Stacy & Oneita TERRAL, I. N. MOORE, Sr., and Dr. Miles S. MOORE and Mrs. Pathenia E. Moore and Mrs. Anna M. Hayes. Mrs. TERRAL is also a member of the Ouachita Club. A former member of the United Daughters of the Confederacy, she is eligible for membership in the Real Daughters of the Confederacy. Mrs. TERRAL worships at the Baptist Church in Dumas and is quite active in religious activities.

The TERRAL-MOORE Hall, a dormitory for Freshman women, is a memorial to her husband, father, and mother.

In 1965, she resided at 124 East Waterman, Dumas AR.



Georgia's Cherokee Country White Men With Indian Families 1830

The following amusing letter concerns a list of 54 white men who had Indian families in what became the last Cherokee land cession in Georgia. The letter is taken from "Cherokee Indian Letters, Talks, and Treaties 1786-1838" (typescript, Louise Frederick Hays, compiler; Atlanta, Ga.; 1938 WPA Project No. 4341), part i, pp. 227-231.

Cherokee Agency
13th Sept. 1830

Sir

Your letter of the 21st ult came to hand this morning, and I have inclosed you a list of fifty four whitemen who have Indian families, and reside within the limits of Georgia, (with their place of residence,) and I have no doubt but that there are nearly as many more, if I could think of their names, or was acquainted with them -- several of their given names of omitted, because not recollected -- The three first on the list are men of Considerable property and several others have a few negroes and some have Considerable stock --

None of them hold any Office under the Cherokee government --

Besides those with Indian families there are about fifty white families who are living in that section, under permits from the Cherokee authorities -- the greater part of them are in the employ of those who have Indian families --

There are also about one hundred white families, who have permits from me, to occupy (untill further orders) plantations which have been abandoned by Emigrants from within the limits of Georgia --

There are mifionarys (viz) Revd. Mr. Thomson and Mr. Proctor at Curmal, and Revd. Mr. Butrick and William Thomson a Blacksmith at Hightower, and Revd. Mr. Worcefter at Newton a Baptist Mifionary at sixes name not recollected, and a moravian Establishment at Spring place and one at Ochkalagee but the names of the superintendants not recollected, But none of them hold any Comifision except William Thomson who tells me he is Clerk of the district Court --

There are also Jacob M Scudder, Reuben Thornton and William S Tarvin, Traders who have License from me, But who having nothing to do with the affairs of the nation-- and several others who have license from the authorities of the nation as Pedlars or stationary Traders--

On the subject of gold digirs, That last accounts give the number at from four to seven thousand; Their morrals are as bad as it is possible for you to Conceive; you Can suppose the gamblers, swindlars, debauchers, and profane Blackguards all Collected from six or seven states without either law or any other power to prevent them from giving vent to their vicious prepenisities, or think of Sodom before the arival of the distroying angils -- and you have some faint Idea of the moralls of the place --

As to resistance against the U States Troops they have offered none; They fly like Blackbirds before the Bayonet, and like them go round and fall in behind

The only thing that we have to Complain of is, that the Civil authority of Georgia so far from afisting us, has by its act encouraged them, by discharging those who we had arested and were attempting to take to Justice, agreeably to the Intercourse Law, which is the only law which we know of that has Cognezince in the case.

To that desition alone may be attributed the failure to keep them off; and the great numbers which have been flocking to the place ever since that desition has been heard of, nor Can it now be stoped untill by Law th offince is mad highly Penal and executed with the utmost regor.
