DICKEN is most likely to contain references to the family you seek.

TERRELL TRAILS page 357, indicates that Sarah TERRELL (10/15/1775--1795+) md. Unknown THURMAN on or before 03/07/1795 when "Sarah TERRELL (now THURMAN) was disowned by Goose Creek Monthly Meeting of Friends for marrying contrary to discipline" [spouse not a Quaker]. Source: *ENCYCLOPEDIA of AMERICAN QUAKER GENEALOGY, Vol VI*, by HINSHAW, pgs 274/276/345/355 South River Monthly Meeting, Virginia. This volume may be available at a nearby major city library or through interlibrary loan. Since THURMAN was not a Quaker, there is little likelihood that their children will be listed in this work.
